**ART. 2.** Primarul prin Aparatul de specialitate va duce la îndeplinire prevederile prezentei hotărâri.

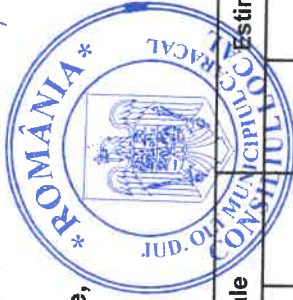

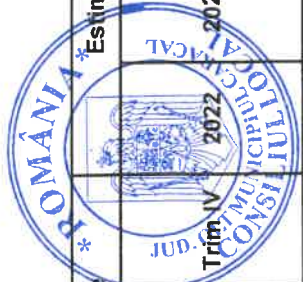
