



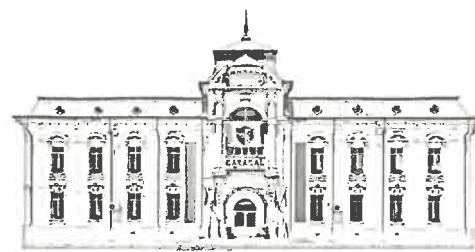

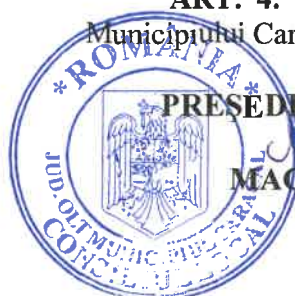
HOTĂRĂȘTE:
